Photography & Filming Guidelines

Thank you for your interest in conducting a photography or video session at Hotel del Coronado. As a National Historic Landmark and one of the most famous resorts in the United States, we are honored to receive a large interest in using the hotel's iconic architecture as the backdrop to so many of life's milestones and special moments.

Due to the large number of requests received and in order to protect the integrity of our guest experience, professional photography and filming is strictly limited at the resort. Hotel del Coronado kindly asks for your cooperation in adhering to our photography and filming guidelines.

GUESTS & DAY VISITORS

The hotel welcomes our guests and visitors to take their own photos and videos with their own devices throughout the public areas of the property or within your guest room, for personal use and to share on social media. Photo shoots with professional photographers or with large camera equipment are not permitted on the hotel grounds. You may conduct a professional photo shoot for personal use with the photographer of your choosing on the public portion of Coronado Beach, located just past the line of Hot Coal Bins. Please be respectful of other beachgoers.

GROUPS, WEDDINGS & SOCIAL EVENTS

Professional event photography is reserved for contracted events only. Please contact sanqq_catering@hoteldel.com if you are interested in hosting your wedding or special event at the resort. If you do not have a contracted wedding at the resort, then professional photography on the hotel grounds is not permitted. You may conduct a professional photo shoot for personal use on the public portion of Coronado Beach, located just past the line of Hot Coal Bins. Please be respectful of other beachgoers.

Conference photography, including speakers, presentations, attendees, activities associated with your event, and meals is permitted in the reserved areas of your event. COMMERICAL USE

Commercial photography or filming anywhere on the premises of Hotel del Coronado and its surrounding 28 acres is prohibited without prior consent from Hotel del Coronado. If the shoot is conducted on the public portion of Coronado Beach and includes any portion of the hotel's exterior façade, prior consent and a License Agreement is also required from Hotel del Coronado.

Any commercial shoots granted by The Del require the following:

- Space fees ranging from \$2,500 to \$50,000 per day. All set-up fees plus food and beverage charges are additional and must be made through the hotel's catering department.
- Signed Global Location Release Agreement between the hotel and the producer.
 - An additional signed License Agreement is also required if the shoot includes recognizable features of the hotel including: the words or logos of "Hotel del Coronado," the exterior façade of any of the hotel's buildings, the hotel's main lobby, or the hotel's Crown Room.
- If drone work is desired, there are additional requirements including proper licensing, FAA clearance, clearance from Naval Air Station North Island, and additional Aviation Liability Insurance and/or a General Liability Insurance Policy with an endorsement covering Unmanned Aircraft Systems (UAS), i.e. Drones, with combined coverage of at least \$3 million per occurrence. We recommend working with our preferred drone operator, Tactical Drone Solutions, at ree@tacticaldronesolutions.com.
- Proof of General Liability Insurance of \$1 million per occurrence/\$2 million aggregate
- List of additional insureds as follows with an endorsement attached: "Hotel del Coronado"; "BSK Del Partners, LLC" "Hilton Management, LLC"
- Proof of worker's compensation insurance if employees are on property.

LOCAL PHOTOGRAPHERS

Local photographers wishing to take architectural photos of the hotel for their portfolio and/or to promote the hotel are welcome to do so on public property, such as from the beach. The hotel works with a list of approved photographers for any onsite photography needs and is not looking for additional photographers at this time.
